Applications are invited **through online** from the eligible candidates for the temporary post of **Young Professional-I (YP-I) (01 No.)** (on contractual basis) to work at **EIS Division** of CIFT, Cochin. The duration of the contract is **for 01 year, extendable up to 03 years (max.)**.

### **I. Young Professional-I :**

Emoluments	: Rs.25,000/- per month (Consolidated)
Essential Qualification	: Graduate and above in Agricultural and allied science preferably in Economics/Sociology/Statistics/Management/Fisheries Extension/ : Agricultural Extension/Fisheries Economics/Agricultural Economics/ : Agricultural Statistics/Bio Statistics etc.
Desirable	: Atleast 3 years' experience in data collection and data analysis in fisheries. Working knowledge on computer applications (MS Word, Excel, PowerPoint etc.), statistical analysis of data and technical writing ability will be considered as added advantages.
Age limit	: Candidates should be above 21 years and maximum of 45 years as on date of interview. Age relaxation as per rules.

3. Age relaxation of 3 years for OBC candidates and 5 years for SC/ST candidates is permissible.
4. Candidate should possess 1<sup>st</sup> class or 60% marks or equivalent overall GPA
5. **Date and time for the online interview will be intimated to the shortlisted candidates in due course.**
6. **The recruitment will be held in strict compliance with the ICAR O.M. dated 04.12.2020.**
7. The selected candidate will be recruited on contract basis under ICAR norms. The post is purely temporary.
